

## Election 2012: U.S. Senate races for Florida, Republican and Democratic primaries

The race for U.S. Senate is heating up.

Four Republicans and two Democrats are battling to be their respective party's nominee.

On the Republican side, U.S. Rep. Connie Mack IV, R-Fort Myers, is hoping to follow in the footsteps of his father, former Sen. Connie Mack III. And while most analysts place Mack in the winner's circle come Aug. 14, it's not a sure thing.

Running against Mack in the Republican primary is Ave Maria resident Marielena Stuart, retired Col. Mike McCalister and former U.S. Rep. Dave Weldon.

The Republican primary may be the race to watch, but Democrats won't be sitting out this primary. Democratic Sen. Bill Nelson will face challenger Glenn Burkett.

Florida is a closed primary state, which means only Republicans and Democrats can vote in their party's primary. The winners face off in the general election in November with several other candidates running without party affiliation or as write-ins.

The winner will go on to serve a six-year term in the U.S. Senate.

This is the eighth in a series of reports about candidates on the Aug. 14 ballot.

**Name: Col. Mike McCalister**

**Born:** Nov. 29, 1951

**How long you've lived in your county:** I have lived in Florida for about 18 years and currently live in Hillsborough County

**Education:** Bachelor's of Science in agriculture from Southeast Missouri State University; a graduate of the Command and General Staff College; a Ph.D. in management from the Union Institute; completed the Air War College Curriculum, and completed the Harvard Program on Senior Executive Leadership

**Family:** Son, 32

**Political affiliation:** Republican

**Current position:** Retired colonel and owner of a small canary tree farm

**Q. What is the first thing you would do if elected?**

A. We need to repeal Obamacare. And we need to have a very comprehensive national security policy that protects our jobs and industries, protects our national security and vital interests, helps us gain energy independence, stops international laws and agendas, and maintains a very strong national defense.

**Q. What would you do to make your community a better place to live?**

A. I would work to get the federal government out of the way of our state's and citizens' rights and to decrease unnecessary regulations that are prohibitive to the growth of jobs and the economy. I would also work to secure the border.

**Q. What makes you the most qualified for this position?**

A. We need to look at this just like we do when we're hiring in the workplace. Look at the committees of the U.S. Senate and at the

Constitutional duties, and I have the best credentials and official experience to conduct those.

**Q. What distinguishes you from your opponents?**

A. I think what most distinguishes me is I have the best credentials and accredited education, such as agriculture and business, national defense and national security, and global business to perform the duties of the U.S. Senate.

**Name: Marielena Stuart**

**Born:** In 1956

**How long you've lived in your county:** I have lived in Collier County since August 2007

**Education:** Linguistics, international and legal conference interpreter; also studied and trained as a concert pianist

**Family:** Husband and two children

**Political affiliation:** Republican

**Current position:** Republican candidate for the U.S. Senate

**Q. What is the first thing you would do if elected?**

A. Dismantle the socialist programs and entities that are destroying the American economy — starting with Obamacare and the EPA. Stop Sustainable Development (Agenda 21) and Public-Private Partnerships (PPPs), which put profits and resources in the hands of powerful private interest collectives (socialists) who seek power and control. PPPs do not represent the interests of the taxpayers.

**Q. What would you do to make your community a better place to live?**

A. I would eradicate sustainable development in Ave Maria and dismantle the Public-Private Partnership (PPP) called Ave Maria Stewardship Community District (the "special purpose local government" in Ave Maria). **Born:** Aug. 31, 1953

**How long you've lived in your county:** 25 years

**Education:** Bachelor's of science, SUNY Stony Brook; Doctor of Medicine, SUNY Buffalo School of Medicine, Buffalo, N.Y.

**Family:** Wife, Nancy, of 32 years, two children

**Political affiliation:** Republican

**Current position:** Private citizen; practicing physician (internist); former member of Congress (1995-2008)

**Q. What is the first thing you would do if elected?**

A. Work to repeal Obamacare. As a physician and former member of the U.S. House of Representatives, (1995-2008), I know how flawed this law is; it is too costly and it transfers decision-making from patients and doctors to bureaucrats. We need to be protecting patients and helping to strengthen their ability to work with their health-care professionals to provide the best health care available, not create another government monster to play Big Brother with our health care.

**Q. What would you do to make your community a better place to live?**

A. Return our nation to a smaller, more responsive government attuned to the constitutional design created by our founding



Bill and working three jobs; Gordon Jr. College, Barnesville, Ga.; Associate's in Arts from Pensacola Jr. College, Pensacola; Bachelor's degree from West Florida University in Pensacola; post-graduate work at Florida State University in Tallahassee; post-graduate work at University of Florida in Gainesville

**Family:** Mother (87 years old) on no prescription drugs; two brothers; all live in Thomaston, Ga.

**Education:** Graduate of Yale University and the University of Virginia Law School; admitted to The Florida Bar in 1968

**Family:** Grace Cavert Nelson, 2 grown children: Bill Nelson, Jr.; Nan Ellen Nelson Dixon

**Political affiliation:** Democrat

**Current position:** U.S. senator

**Q. What is the first thing you would do if elected?**
